

# Did You Know?

Vancouver/Richmond Health Board Announces Expanded Sobering and Detox Services for the Region

On Friday, February 18, 2000, the Vancouver / Richmond Health Board announced a regional plan for expanded and improved sobering and detox services for managing alcohol and drug addictions.

These services will be housed in a Sobering Centre that will be located in the Downtown Eastside. The sobering and detox services provided will have a public health focus rather than a criminal justice approach. Services will include a full range of support such as detoxification,

## Vancouver-Richmond Health Board Fighting Disease in Downtown Eastside

Influenza and a Pneumonia: a The Board is working in the Downtown Eastside to immunize residents against. influenza and pneumonia. With the help of nurses and volunteers, nearly 9,000 people were vaccinated in December 1999. This is the first time in Canada that the pneumococcal vaccine

has been distributed en masse.

#### Hepatitis A:

In Vancouver, the Hepatitis A infection is more than four times the national average. To stem the spread the Board is initiating a large-scale immunization program in the Downtown Eastside. Immunization teams in single-room occupancy hotels, clinics and agencies are expected to reach 8,000 people.

#### Syphilis: 💩

There has been a marked increase in the number of people contracting syphilis in B.C. in the past two years. To stop it from spreading further, a treatment campaign will be provided by street nurses, clinics and other public health offices at several sites in the Lower Mainland from January 24-28, 2000. During this week a Syphilis Information Line has been set up to answer questions from the public (660-6768).
