# THE CONTINUING SAGA OF HUNGRY KIDS

Last April End Legislated Poverty and other groups had a forum on Child Poverty.

Lots of low inocme people spoke out about poverty and hunger. The newspapers and TV did lots of stories about hungry children.

that children should be fed in school.

ELP and other groups went to the School Board and asked for a proper meal program in schools. We said that all kids should be able to eat there. No one should be singled out as poor.

The School Board got lots of publicity. They said they were feeding 600 kids. But they only spend \$25,000 to do this. That's only about three meals a month for each of the 600 kids. It is nothing for other kids, too embarrassed to say they're hungry. It's nothing for kids who are afraid of being taken from their families if they say they are hungry.

The federal government said they might pay for half of a good food program. Then, early this month, they said "no". (continued on page 2)

Vander Zalm said he won't pay either.

ELP and the Child Poverty Action Committee are still working with teachers and parents to get a good food program in school. We also want increased welfare and minimum wages.

- l. Learn as much as you can about GAIN: what it means and what you may be entitled to.
- 2. Always ask your worker when you have questions or concerns about benefits. Be sure to ask if you think you may be eligible for other benefits.

#### GET DAYCARE?

Any person on GAIN can apply for daycare for their children. You will likely get day care if:


\*\*you have a job, full
time or part-time;
 \*\*You are attending
school;

\*\*You are looking for a job;

#### YOU CAN GET

definite job. If you need clothes and bus-fare to apply for jobs, you can ask your worker for this also.

\*\*An extra \$20 a month for any family member on a special diet, prescribed by a doctor, such as a diabetic diet.



\*\*You have to attend
some kind of a treatment
centre:

\*\*You are now with your children every day and it is really getting you down.

\*\*For pregnancy, \$425 a month until the baby is seven months old. Take a note from the doctor to your worker.

\*\*Moving costs up to a total of \$500, if the move is to a home where the total cost of shelter is less than your present cost.

#### POWER PLAY REPORT

End Legislated Poverty and Headlines Theatre teamed up to create a Power Play. A group of lower income people who use the food banks were involved. David Diamond and Sherri Lee Guilbert led us through a series of trust/co-operation games and relaxation exercises.

We expressed feelings of oppression relating to situations at food banks. A short play was created by combining them all together.

The play took place at Carnegie Centre at 7pm on Feb. 28th. The play was in three steps.

The beginning portrayed a line up outside the food bank. The second part consisted of the situation inside the food bank and the third part was at a bus stop afterwards.

The idea of the play was to run through it once to show it to the audience. Then we started the play the second time. If someone from the audience saw someone being oppressed and felt they could solve a problem, they could stop the play.

They would then become a part of the play by taking another's place. In most cases the problems were solved by co-operation.

Although we are very thankful to have food banks that help us out, the play was merely to show oppression. Not only did many of us become friends, but also it was a learning experience and a lot of fun for everyone involved.

## OUR KIDS AREN'T DUMB!!!
