We know that the socreds sent a Cabinet Minister to Britain to study privatization.

TRY TO GET A DIET ALLOWANCE

Do you need more money to survive on welfare? You might be able to get an extra \$20 a month for a dietary allowance. This is not a sure thing, but you may have a chance.


allowance, you may want to get help from one of the groups on the back. They will help you appeal and you might win.

If you are overweight, underweight, diabetic, or need special help with your diet that you can't afford on welfare, ask your doctor or a dietician for a letter.

The letter should state:

- 1. The physical condition requiring the diet.
- 2. The therapeutic diet required, and
- 3. The duration of the treatment (for example, three months).

Give this letter to your worker. If you are denied the diet

Don't sell your tax and lose money.

MAN ON WELFARE TAKES



A Manitoba man on a disabled pension took the government to court and won!! His name is Robert James Finlay. He has been fighting the government for 14 years.

His victory may help other people on welfare.

This is what happened:
The Manitoba government
was taking money off Mr.
Finlay's disability
cheque. The government
said Mr. Finlay owed
them money. Mr. Finlay
appealed 23 times and
lost every time. Then
he got a lawyer and took
the government to court.

The case took years. But finally Mr. Finlay won.

The judge ordered the Government of Canada to stop paying Manitoba \$14 million a month if Manitoba does not stop deducting money from people on welfare.

The decision may help people in B. C. in two ways. It may be illegal for SS&H to deduct money from cheques for overpayments. Lots of people on welfare have to pay back money for security deposits or food vouchers.





GOVERNMENT--AND WINS!!!

Sometimes they have to pay back money if their cheque is stolen and SS&H pays extra money for rent or food.

Some lawyers are looking at this question for End Legislated Poverty. We are not sure that we will be able to use the courts to stop these deductions. But we have a chance.

Also, Mr. Finlay's court case may help us get governments to raise welfare rates. Several mes End Legislated Poverty has asked the socreds to prove that a person could live on the amount that welfare pays. The socreds didn't answer. But the judge said that Manitoba has to stop deducting from Mr. Finlay's cheque because he didn't have enough money to meet his "basic requirements."

End Legislated Poverty may be able to start a court case about this. We could argue that welfare of \$430 per month doesn't meet "basic requirements". This is not a sure thing. But it is a possibility, thanks to Mr. Finlay.


IN STITCHES
