On July 19th about 10 members of End Legislated Poverty handed out leaflets to people who attended the musical play, Les Miserables.

The play is a musical about poverty in the 1800's. Tickets cost \$31.75 to \$58.75. So poor people in Vancouver can't afford to go.

The lealets said that poverty is still miserable in 1990. They asked the people who attended the play to help us end poverty.

Some people who were going to the play were very nice. They seemed to agree with the leaflet. Others



said ELP was ruining their evening.

WOMAN ON WELFARE WINS BACK MAINTENANCE PAYMENT

A woman on welfare won an amazing appeal in June. The woman's expartner owed her back maintenance payments. Finally he paid in a lump sum. Naturally, welfare tried to take the money, and let the woman keep only \$100.

The woman appealed and won!! Now she gets to keep the usual \$100 a month PLUS an extra 100 until the back payment is used up.

A young lawyer presented the case for the woman. Margaret Ennenberg of the Unitarian Church was on the Tribunal. The lawyer said that the Family Maintenance Act is part of the GAIN ACT. The GAIN act says that the purpose of income assistance is to "relieve poverty, neglect and suffering."

If you have a problem like this with maintenance payments, see one of the groups on the back page. They may be able to help you win.

SCHOOL START UP FUNDS INCREASE

Are you on welfare? If you have children in school, make sure that you get the school start up money for them. The new rates are \$35 for children aged 6 to 11; and from \$47 to \$50 for children 12 and above.

If you have made the choice to stay home with your children, we support your right to having this choice.


MSSH declares a single parent with children over 6 months to be "employable" no matter how many children they have.

SCHOOLS GET \$200,000 MORE FOR FOOD

On July 12 Vancouver City Council passed three motions. They agreed to give the School Board \$200,000 to expand the food program to a high school. They set up a committee to work on getting higher welfare and wages and more money for food programs. They agreed

to appoint a representative of End Legislated Poverty to the committee.

Several weeks before, a group of low income women had asked council to expand the food program. They also wanted higher welfare and wages. Now we'll see if City Council really acts, or if it just passes resolutions.









GET YOUR OWN FIGHTING POVERTY KIT



A Legislated Poverty has produced a new Fighting Poverty Kit for low income people. The kit has two kinds of information. It has information about your rights. Pamphlets on welfare and tenant rights are in the kit. It also has pamphlets from the Ombudsmans Office and the Voter Office.

The kit also has information about how to fight against poverty. It has a sheet on how to run meetings. There is information on fighting for a food program. One page tells you how to write a letter to a politician. Addresses of B. C. politicians are included. There is information on the corporate agenda, and a little envelope of strings. Each string is cut to show the wealth of one fifth of Canadians. The string for poor Canadians is less than an inch long. The string for rich Canadians is nearly 69 inches long.
