NEWS FROM THE ADVOCATES

Consumer Legislation

An Act to Amend the Bankruptcy and Insolvency Act, The Companies' Creditors Arrangement Act, and The Income Tax Act (Bill C - 5). Most of the changes will come into force this autumn, according to the Office of the Superintendent of Bankruptcy. Highlights of the legislation include:

- Income support benefits, such as GST refunds and Child Tax Benefits, will be exempt from seizure.

- Maintenance under court order or agreement will have priority status for the amounts accrued in the year before bankruptcy.

- Civil judgments for damages for sexual or physical assault will be non-dischargeable.

- Surplus income payable to the Trustee under the Superintendent's

guidelines will depend on the cost of living in different areas.

- Student loans will be non-

dischargeable if the person files within two years of finishing school, or while still in school. After two years, the court can review and discharge all or part of the debt.

- In an opposed discharge, the Court can award costs in favour of a creditor, to be paid out of the estate.

Courts Legislation

Miscellaneous Statutes Amendment Act, 1997 (Bill 22) Sections 32 and 33 of this act affect the conditions for the right of appeal under the Small Claims Act. Effective for all appeals filed on or after September 1, 1997, an appeal will be based on the record from the provincial court trial, on questions of fact and law. This replaces the current appeal process which consists of a new trial in Supreme Court.

Court Rules Act

Amendments to the Small Claims Rules were brought into force on June 15, 1997. Some of the changes are: - Parties must now bring all relevant documents and reports to the settlement conference. Before, parties had to bring just the documents and reports they were going to rely on at trial.

- The judge may also now dismiss a claim, counterclaim, reply, or third party notice if it is frivolous or an abuse of the court's process.

- Rule 7.1 allows the transfer of claims to Supreme Court where the monetary outcome of a claim may exceed \$10,000. This rule also establishes the right to hold one trial with multiple causes of action, even though the total monetary outcome of all the claims is likely to exceed \$10,000.

- Rule 10.1 provides an incentive for parties to file and accept formal offers to settle. It will likely be helpful initially for a judge to raise this at the settlement conference, especially in cases where one party refuses a reasonable settlement offer.

MHR and damage deposits

Tenants are now responsible for their own collection of damage deposit refunds. As of August 1, tenants no longer assign their damage deposit

refunds to the Ministry of Human Resources. Tenants may have to go to the Residential Tenancy Branch. and on to Small Claims Court for collection. There does not seem to be any special consideration given to tenants who have an RTB order for return of deposit but can't collect on it. This means that advocates will need to give more attention to requests for assistance with collection at both the RTB and small claims levels. MHR will keep paying out new damage deposits, but will immediately sing repayment agreements with the tenant and arrange monthly deductions until past security deposits are repaid in full. Probably these deductions will be individually negotiated in the range of \$5 to \$15 a month.

All damage deposits issued before August 1, 1997, remain under the old rules. Previous damage deposits will not automatically be subject to repayment by the tenant to MHR.

Same-Sex Couples recognized as Spouses

Gays, lesbians, and bisexuals may find the recent passage of Bill 31, amending the Family Relations Act, the changes mean that same-sex couples who have lived together for two years are classified as "spouses" and have the same rights and

continued from page 3 obligations as opposite-sex commonlaw couples. Upon separation, the parties may make claims for maintenance, child custody, and access. The property division and pension sharing regimes of the act will not apply unless the couple has specifically opted into it by making an agreement.

The changes also mean that transgendered people will not have to present evidence that they are one gender or another in order to determine whether or not they can make a claim for maintenance from an ex-partner. (In an Ontario case, a female to male transsexual man was denied the right to claim maintenance from his ex-common-law wife after an 18-year relationship because he did not meet the judge's criteria for "male." Another change is that abused partners in same-sex couples may now apply for a restraining order under

the act. Previously, the only option for an abused partner was to get a peace bond under section 810 of the Criminal Code, which required the cooperation and assistance of the police and Crown prosecutors. The act could now apply to same-sex couples who were separated within the past year (there is a one-year limitation period), after having lived together for at least two years. Practically speaking, relationship agreements between partners in same-sex couples are now very important for those who don't wish to have the Family Relations Act govern the structure of their relationships, and for those who do not wish Parts 5 and 6 to apply (property division and pension sharing). Note: FRA amendments are not yet proclaimed in force.
