Our organization has attempted to obtain information regarding certain actions of the City of Vancouver on 22 September of this year. We approached

City Council directly at their public meeting on 22 October of this year and

asked that "the City disclose all information regarding the involvement of the Engineering Department in the [Vancouver] Police [Department] actions of

22 September." These actions, as you may know, involved City employees, vehicles, and equipment in the destruction of the personal property of at least 100 of Vancouver's homeless citizens who were attempting to camp on Abbott Street that night. We have made numerous subsequent informal requests

to the City since our appearance at the City Council meeting of 22 October and have received no reply regarding our inquiries. We believe that the documents pertaining to this incident exist in the files of the Engineering Services Department and Office of the Mayor. Additional documents pertaining

to this matter may exist in the files of the Law Department.

As the route of informal requests appears to be exhausted, each of the affected citizens shall be filing a formal freedom of information request. Our organization seeks to co-ordinate this effort with your office so as to make this request process as manageable as possible. Please let us know if there is anything we can do to assist you over the course of the next few months.
