Dear Mayor Campbell,

You need to meet with representatives from the Woodward's Squat Negotiation Team (WSNT) today. We must come to an agreement about the conclusion of the squat and your proposal to move the community to the Dominion Hotel. We received correspondence yesterday from an assistant to Cllr Jim Green stating that he is unavailable to meet until next week. Yet other City of Vancouver staff, Portland Hotel Society staff, Dominion Hotel owner Nasser Nabahat, and Jim Leyden from the Woodward's Social Housing Coalition have all

told the Woodward's Squat residents on your behalf that we should be expecting to move on Saturday 14 December 2002 at noon. We are confused. The

WSNT has not even been able to schedule a preliminary negotiation meeting with City Council. You need to call our negotiator Reverend Davin this morning at the Woodward's Squat Emergency Response Line (604-727-8471) so we may resolve this matter. We need to resolve this matter today as we are expecting our first fatality from untreated illness at the Woodward's Squat over the weekend.
