## **WOODWARDS LEGAL DEFENCE COMMITTEE UPDATE**

As of Thursday, October 24, 2002, there is **\$2415.55** in the **Woodwards Legal Defence Fund**.

The **Woodwards Legal Defence Fund** has been set up to defend the 54 Squatters and Supporters who have been charged with civil contempt of court and face their first court appearance on November 7, 2002. The **WLDF** also has responsibility for any legal actions relating to the arrests of Squatters and Supporters inside the Squat on September 21, the arrests of Squatters and Supporters outside on September 22, and the theft/destruction of property on both dates.

People wishing to contribute to the **WLDF** should be asked to make a cheque payable to "Woodwards Legal Defence Fund," and mail to Woodward's Legal Defence Fund, P.O. Box 21552, 1850 Commercial Drive, Vancouver, BC, V5N 5T5.

The **Woodwards Legal Defence Committee** is a committee of the "Coalition of Woodward's Squatters and Supporters" and is accountable to that organization.

The **WLDC** is made up of Calvin, Jess, Megan, Benerice and Michael (Supporters arrested and charged on September 21), Angel (Squatter arrested and charged on September 21), and Aaron (from "Friends of the Woodward's Squat").

Our next meeting is **Sunday, October 27/02 at 11:30 AM**, at the **Kootenay School of Writing Office** (which is near the Squat; for exact location and directions, talk to Aaron).
